 - (C) Letter of technical tender.
 - (D) Tender's information sheet.
 - (E) Specific Construction Experience.
 - (F) Construction Experience in key activities.
 - (G) List of key Equipments/Machines certificate.
 - (H) Declaration, check list for technical tender evaluation and integrity pact on non judicial stamp duly signed with name of work.
 - (I) All desired document should be self attested except Affidavit which is to be submitted on stamp paper duly Notarized not below Rs. 100
 - (J) PAN No. details.
 - (K) Copy of valid registration in CGPWD/ Central/State/Semi Govt. of india or PSU of appropriate clause.
 - (L) Tenderer has to submit Audited balance sheets of their financial turn over/accounts along with profit & loss account for the last three (3) complete financial years duly certified by CA.
 - (M) The contractor shall submit list of works which are in hand, in the specified form only.
 - (N) GST will be applicable & shall be paid by contractor.
 - 2- All the contractors are required to submit Envelope A & B physically containing the following Document:

4- If any document as required is not received as per the desired form then the Bidder will be treated unqualified

- 5- 5% amount of the value of work done on every running bill will be deducted till the sum along with the sum already deposited as earnest money, will amount to security deposit of 5% of the tendered value of the work.
- 6- The successful tenderer, upon issue of letter of acceptance, in addition to execution of an agreement on a non judicial stamp paper of appropriate value, shall also be required to furnish an irrevocable Performance Bank Guarantee equal to the amount of 5% of tendered value of work. Within 15 days of the issue of the letter of acceptance/award of Tender by the CSIDC. In the event of failure on the part of the successful tenderer to furnish the Performance Bank Guarantee within specified period, the earnest money will be forfeited and tender shall be cancelled.
- 7- Conditional tenders are liable for rejection.
- 8- Any amendment issued shall be part of the tender document and shall be published on the website only and shall not be published in any newspaper.
- 9- (a) cess @ 1% (one percent) shall be deducted at source from every bill of the contractor under Building and other construction for workers welfare, cess act 1996.
 - (b) It is mandatory for the contractor to get him/them self registered with C.G. Building & other construction welfare Board as soon as The work order is issued to him/them for The works amounting to Rs. 10.00 (Ten) Lacs and above and submit a copy of the same to the concern Executive Engineer. Other wise no payment will be made under the contract.
