 - (iii) (a) The layout plan of proposed industrial area must be prepared as per the norms of the Town & Country Planning Deptt. and also get approval from Local/Distt office/ Town & Country Planning Deptt./ Town & Country Planning directorate.
(b) They must also take NOC from pollution Control Board, PWD, CSEB, WRD & PHE of local distt. Govt. Department.
(c) It will be responsibility of the agency to get approval of Layout Plan from concerned Town & Country Planning Department/ Town & Country Planning directorate.
 - (iv) To Provide technical support & Assistance including submission of the layout plan with signature of Registered Town planner for clearance and approval of layout plan from Town & country planning deptt. shall be the responsibility of the concern agency as per the requirement of Town & Country planning deptt.
 - (v) It will be responsibility of the agency for the demarcation of proposed land periphery & road Industrial Plots etc. including concerning with Govt. revenue department i.e.. SDM/Tahasildar/RI/ Patwari of the proposed area.
